RECTOR'S ORDINANCE on determining the amount of fees related to studies for the academic year 2025/2026

Article 1 Introductory provisions

1. This ordinance, in accordance with Article 27(3) of the Statutes of the University of South Bohemia in České Budějovice (hereinafter referred to as 'Statutes') sets the amount of fees associated with studying at the University of South Bohemia in České Budějovice (hereinafter referred to as 'USB').
2. The interpretation of this ordinance is entrusted to the Vice-Rector for Student Affairs, who also decides and acts on matters not covered by the ordinance, if such decisions concerning them and actions are necessary for the implementation of this ordinance.

Article 2 Fee for acts related to the admission procedure

The amount of the fee pursuant to Article 27(2)(a) of the Statutes relating to admissions commencing in the academic year 2025/2026 is CZK 700.

Article 3 Fee for acts related to the admission procedure for studying in a foreign language

1. The amount of the fee referred to in Article 27(2)(b) of the Statutes relating to admissions commencing in the academic year 2025/2026 shall be, in the case of
 - a. Faculty of Theology, Faculty of Economics, Faculty of Education, Faculty of Science and Faculty of Arts CZK 1 000,
 - b. Faculty of Fisheries and Water Protection CZK 1 500,
 - c. Faculty of Agriculture and Technology € 500.
2. An applicant who paid the fee in the amount referred to in paragraph 1(c) and was not admitted shall be refunded the amount of €460 within 15 days of the entry into force of the decision on non-admission in the same manner as the manner in which the fee was paid.



Article 4

Fee for studies pursuant to Section 58(3) of the Act

1. The amount of the fee referred to in Article 27(2)(c) of the Statutes for the academic year 2025/2026 shall be the following, in the case of
 - a. Faculty of Economics and Faculty of Fisheries and Water Protection CZK 25 000 for every six months of studies commenced,
 - b. Faculty of Arts CZK 16 940 for every six months of studies commenced,
 - c. The Faculty of Theology CZK 33 880 for every six months of studies commenced,
 - d. Faculty of Health and Social Sciences CZK 20 570 for every six months of studies commenced.

2. The amount of the fee under Article 27(2)(c) of the Statutes for the academic year 2025/2026 is set according to the number of months by which the student exceeded the period of studies for which the fee is payable under Article 58(3) of the Act (i.e. by how many months the student exceeded the standard period of studies increased by one year, which also included the periods of all previous studies in bachelor's and master's degree programmes which were completed otherwise than duly with corrections if necessary under Section 58(3), as follows:
 - a. Faculty of Education
 - i. if exceeded by less than 12 months, CZK 16 940 for every six months of studies commenced, and
 - ii. if exceeded by 12 months or more, CZK 33 880 for every six months of studies commenced,
 - b. Faculty of Science
 - i. if the period is exceeded by less than 6 months, CZK 12 000 for every six months of studies commenced,
 - ii. if the period is exceeded by 6 months or more but less than 12 months, CZK 20 000 for six months of studies commenced,
 - iii. if the period is exceeded by 12 months or more but less than 18 months, CZK 30 000 for six months of studies commenced,
 - iv. if the period is exceeded by 18 months or more but less than 24 months, CZK 35 000 for six months of studies commenced,
 - v. if the period is exceeded by 24 months or more, CZK 40 000 for six months of studies commenced.
 - c. Faculty of Agriculture and Technology
 - i. if the period is exceeded by less than 6 months, CZK 25 000 for six months of studies commenced,
 - ii. if the period is exceeded by 6 months or more but less than 12 months, CZK 30 000 for six months of studies commenced,
 - iii. if the period is exceeded by 12 months or more but less than 18 months, CZK 35 000 for six months of studies commenced,
 - iv. if the period is exceeded by 18 months or more but less than 24 months, CZK 40 000 for six months of studies commenced,
 - v. if the period is exceeded by 24 months or more, CZK 45 000 for every six months of studies commenced.



Article 5

Fee for studying in a foreign language

1. The annual amount of the fee referred to in Article 27(2)(d) of the Statutes, for the standard period of studies of a student in the first semester of studies in the academic year 2025/2026, is set in the case of
 - a. Faculty of Economics in the amount of
 - i. €100 for the Consecutive master's degree programme in Regional and European Project Management (REPM),
 - ii. €3 300 for a doctoral programme,
 - b. Faculty of Arts in the amount of CZK 500,
 - c. Faculty of Education in the amount of CZK 168 000,
 - d. Faculty of Science in the amount of
 - i. CZK 0 for the Consecutive master's degree programme in Functional Genetics and Bioinformatics in accordance with the project NPO Trasformace-JU, reg. no. NPO_JČU_MŠMT-16608/2022,
 - ii. CZK 440 for the bachelor's and master's degree programme in Biological Chemistry,
 - iii. CZK 12 000 for the degree programme Ecology,
 - iv. CZK 20 000 for doctoral degree programmes,
 - v. CZK 24 000 for the MAID degree programme 'Artificial Intelligence and Data Science' (MAID),
 - vi. CZK 500 for the programmes listed under points iii. to v., if the student is a citizen of a Member State of the European Union,
 - e. Faculty of Fisheries and Water Protection in the amount of
 - i. CZK 500 for doctoral degree programmes,
 - ii. € 500 for consecutive master's degree programmes,
 - f. Faculty of Theology in the amount of CZK 40 000,
 - g. Faculty of Agriculture and Technology in the amount of €3 000.
2. If the Dean issues a decision on the fee separately for each semester of studies, he or she shall assess the fee in an amount corresponding to one half of the amount determined pursuant to paragraph 1.
3. If the Dean of the Faculty of Science issues a decision on the tuition fee or the MAID degree programme 'Artificial Intelligence and Data Science' (MAID) for a semester of studies during which the student is enrolled only in courses at a partner higher education institution, the fee is set at the semester amount of CZK 500.
4. The amount of the fee referred to in paragraph 1(g) shall be reduced by €460 in the first year of studies.
5. The Dean of the Faculty of Economics may set a fee pursuant to paragraph 1(a)(ii) in an amount lower than the specified amount in the case of above-standard fulfilment of the study obligations



specified in the Dean's ordinance on doctoral studies.

Article 6

Fee for acts related to the assessment of the fulfilment of the condition for admission to studies

1. The amount of the fee referred to in Article 27(2)(e) of the Statutes relating to admissions commencing in the academic year 2025/2026 is
 - a. CZK 0 in the case of the Faculty of Fisheries and Water Protection and the Faculty of Health and Social Sciences,
 - b. CZK 700 in the case of the Faculty of Theology,
 - c. CZK 990 in the case of the Faculty of Economics, Faculty of Arts, Faculty of Education, Faculty of Science and Faculty of Agriculture and Technology.
2. If an applicant proves that he or she meets the condition referred to in Section 48(1) or (3) in more than one parallel admission procedure with an identical foreign document, he or she shall pay the fee for its assessment in only one of them.

Article 7

Transitional provisions

1. For the tuition fee pursuant to Section 58(3) of the Act set in the period from 1 September 2025 to 28 February 2026, the amount of which is set out in Article 4(1) of this ordinance, it shall be set in the amount determined in Article 4(1) of this ordinance, but not more than the amount determined for the academic year 2024/2025 increased by CZK 5 000.
2. For the tuition fee pursuant to Section 58(3) of the Act set in the period from 1 September 2025 to 28 February 2026, the amount of which is determined in Article 4(2) of this ordinance, it is set
 - a. in the event of exceeding the studies defined in Article 4(2) by less than 6 months in the amount determined in Article 4(2)(b)(i) for students of the Faculty of Science and in the amount determined in Article 4(2)(c)(i) for students of the Faculty of Agriculture and Technology,
 - b. in other cases in the amount determined in Article 4(2)(a)(i) for students of the Faculty of Education, in the amount determined in Article 4(2)(b)(ii) for students of the Faculty of Science and in the amount determined in Article 4(2)(c)(ii) for students of the Faculty of Agriculture and Technology.

Article 8

Final provisions

This measure takes effect on 28 February 2025.
