### BANK AT WORK TERMS AND CONDITIONS

**Current account** – The reward is paid for a period of up to 6 months in the amount of CZK 500 per month and a total amount of up to CZK 3,000 per year, provided that 3 transactions are made with a payment card and a salary of at least CZK 10,000 is sent every month. In the event that another banking product is negotiated during the payment of the bonus in the form of CZK 500 per month, this benefit is paid for another 12 months, i.e. for a total of up to 18 months and in the total amount of up to CZK 9,000. The account is maintained free of charge in the event of the START service package being negotiated, or when the TOP service package is being negotiated and ensuring an incoming payment of a minimum amount of CZK 40,000 per month.

**Interest rate** – The interest rate is for deposits up to 2,000,000 CZK and is linked to the second current account in CZK. Detailed conditions of the interest on deposits are available at [www.unicreditbank.cz/ucty](http://www.unicreditbank.cz/ucty).

**Investment** – A 50% discount applies to the ongoing entry fee paid on a regular investment based on an instruction. A 50% discount applies to the entry fee for arranging a one-off investment based on an instruction. A 75% discount applies to the entry fee for arranging a one-off investment based on an instruction if the volume of savings and investments is at least CZK 1 million.
